# **Motion** to approve the agenda

Motion adopted unanimously

Knowles introduced Charles Wilkins, legal counsel for the North Carolina Board of Massage and Bodywork Therapy.

Wilkins welcomed all attendees to North Carolina.



#### **President's Report**

Knowles presented a summary of FSMTB activities and the regulatory landscape over the past year. He spoke about communication regarding COVID-19 guidelines for practice, steps the FSMTB has taken to meet strategic goals, the progress of IMpact, the 2022 Practice Analysis, FSMTB programs and resources (MBLEx study tools, REACH, CE Registry), public safety concerns (monkeypox, harassment of massage therapists, and the FSMTB Human Trafficking and Fraud in Higher Education Toolkit). Knowles also spoke about collaborative efforts made by FSMTB with external agencies. Lastly, he expressed his appreciation for the FSMTB volunteers, staff and members.

#### **Treasurer's Report**

Knowles introduced Sandy Anderson, FSMTB Treasurer and Executive Director of the Nevada State Board of Massage Therapy to give the Treasurer's Report.

Anderson introduced and thanked the finance committee: Ed Bolden-Greer (TN), Linda Lyter (WV), and Keith Warren (AL).

Anderson reported that FSMTB's total assets are \$16,762,420. FSMTB's annual income for FY2021-2022 was \$4,391,075 with expenses of \$3,988,587 resulting in a net income of\$402,488 for the fiscal year. Anderson then reported on FSMTB's income and expenditure sources, noting that volunteers help keep operating expenses down and encouraged members to volunteer.

#### Massage Board Executive Summit Report

Anderson announced the 2023 Massage Board Executive Summit will be held April 27-28, 2023, in Denver, Colorado. She also noted the addition of an inspector/investigator track at the summit and encouraged boards to start looking into finances to send their executive directors and inspectors/investigators.

#### **Presentation of Slate of Candidates**

Knowles introduced Megan Maxey, chair of the nominating committee.

Maxey introduced nominating committee members Carla Hedtke (WI), Karen Armstrong (MI), and Kimberly Hodge (TN), and provided the Nominating Committee report to the membership.

#### Optional Wellness Break

Knowles welcomed students and faculty from Piedmont Community College in NC who were in attendance to provide supervised chair massage.

#### **Responding to Illicit Massage Business**

Knowles introduced Robert Beiser, Strategic Initiatives Director at Polaris

Beiser presented on identifying and reporting Illicit Massage Businesses (IMBs); statistics on IMBs in the US, discussed goals of massage regulatory agencies, law enforcement and human trafficking resources.

#### **Community Donation: Dahlia Grove**

Knowles introduced the executive director and board member from Dahlia Grove, a local North Carolina nonprofit social enterprise seeking to empower and employ women survivors of human trafficking, domestic violence and sexual exploitation. On behalf of the FSMTB, Knowles presented Dahlia Grove with a donation of \$5,000.



#### **Interagency Collaboration**

Knowles introduced Doug Gilmer, PhD (Resident Agent in Charge, Homeland Security Investigations).

Dr. Gilmer presented on the importance of interagency collaboration in relation to preventing human trafficking, the history of human trafficking in the U.S., and a multidisciplinary approach to addressing human trafficking.

#### **Member Reports/Forum**

Dale Atkinson, FSMTB legal counsel facilitated the session.

Common topics of discussion included difficulty filling vacant board positions and meeting quorum, reduction in number of licensees, distance education for initial licensing and license renewal, scope of practice, apprenticeships and certified mentorship programs, complaint and application processes, and establishment licensure.

# **Volunteer Recognition**

Dr. Debra Persinger, FSMTB executive director recognized Kimberly Hodge, former nominating committee member from Tennessee; members of the FSMTB board of directors who have completed their terms of service on the board in 2021 and 2022 – Victoria Drago, Caroline Guerin, Charlene Russell; Past President David Cox and President Craig Knowles.

Knowles reiterated appreciation to outgoing board members Guerin, Cox, and Russell for their service.

# **2023 Annual Meeting**

Knowles announced that the date and location of the next Annual Meeting will be September 28-30, 2023 in San Diego, California.

Ahmos Netanel, CEO of CAMTC provided information about San Diego and welcomed FSMTB and its members on behalf of CAMTC to California next year.



#### **Addressing Sexual Misconduct Allegations**

Persinger introduced Dr. Michael Fogel, forensic psychologist and founder of Redirect Risk.

Fogel discussed the impact of sexual assault on victims, and the implications for policy and legal reviews, provided a model approach to addressing sexual misconduct allegations, a rapid response case investigation framework, clusters of offending behavior (lack of policy knowledge, lack of appreciation of client vulnerability, intentional misconduct), and presented case studies.

#### Massage Education

Mai Lin Petrine, FSMTB Director of Legal and Regulatory Affairs and Kevin Snedden, FSMTB Director of Industry Relations were introduced and led a discussion of scenarios illustrating the current status of massage therapy education and the intersection with regulation. They provided examples of current challenges facing the regulatory community and members participated in developing solutions.

#### **Interstate Massage Therapy Licensure Compact**

Matthew Shafer, Deputy Policy Director, National Center for Interstate Compacts, The Council of State Governments addressed the purpose of occupational licensing and reviewed the requirements to adopt the Interstate Massage Compact (IMpact)

Dr. Persinger Executive Director, Federation of State Massage Therapy Boards discussed the Massage Therapy Licensing Database (MTLD) and its relation to the compact.

# **Regulation of Establishments: Panel Discussion**

Sandy Anderson (NV) moderated the panel discussion. Paul Andrews (MA), Gerald Padgett (FL), Keith Warren (AL), and Jan Shaw (SC) served as the panelists.

Some of the topics discussed included adoption of establishment licensure in Massachusetts, South Carolina, Florida and Alabama and the relationship between human trafficking, illicit business and establishment licensing. The panel also discussed some of the requirements their states have for massage establishments such as hours of operation, facility exemptions, random inspections and licensing credentials held by the establishment owner. The panel reviewed the benefits of establishment licensing such as inability of owners to deny inspections and increased ability to identify illicit businesses, and challenges to establishment licensing such as difficulty locating illicit businesses or conducting business outside of the board's scope of practice.



# **Trauma: Survival Skills for a New World**

Knowles introduced Chris Smith, Trauma Touch Therapist, Director of Colorado School of Healing Arts.

Smith discussed the prevalence of mental health issues in America and provided an understanding of trauma and how it can manifest. Smith also provided ways to create a psychologically safe workplace and discussed strategies to combat trauma.

### **Top Regulatory Law Cases**

Dale Atkinson, FSMTB legal counsel with The Atkinson Firm, reviewed top regulatory law cases across all professions. He began by providing members with information on new legislation being passed in the regulatory arena and reviewed the top types of cases seen in regulated professions.
